Pennsylvania Rabbits Requirements:

- 1. The Exhibitor's signature on the Livestock Entry Form affirms that a veterinaryclient-patient relationship is in place.
- 2. All animals must be free of infectious and contagious diseases.

Out of State Rabbits Requirements:

- 1. A Certificate of Veterinary Inspection (CVI) issued within the 60 days prior to the opening date of the exhibition is required.
- 2. All animals must be free of infectious and contagious diseases and a statement of this is required on the CVI (the statement is pre-printed on the CVI).
- 3. An *Animal Owner or Caretaker's Verification of Veterinarian-Client-Patient* upon arrival at the exhibition.

GENERAL RULES:

- 1. The Department chairman reserves the right to refuse any animal that appears unsuitable for exhibit due to unthrifty or unhealthy condition.
- 2. Bring food for animals. Each exhibitor is responsible for the care and feeding of his or her own animals.
- 3. Exhibitor must be present for the judging or arrange for someone to show the rabbit for them.
- 4. Rabbits must be clean when they are entered.
- 5. Litter must consist of four (4) or more bunnies and kittens must be at least five (5) weeks old. It will be the chairperson's discretion to reject entry if rabbits in litter are too old to be considered.

6. Grade (mixed breed) litters will not be accepted

- 7. Rabbit classes are open to any breed. Rabbit chairman has final decision as to how breeds are divided. Grade (mixed breed) rabbits are welcome.
- 8. Department chairman has the final judgment in resolving any dispute.
- 9. All rabbits must be pre-registered before August 16, 2024.
- 10. All entries must be entered with the chairman, on Monday, Aug. 26, 2024 between p.m. to 9 p.m.

LIVESTOCK CLUB MEAT CLASSES

Rabbits entered in a Meat Pen must be bred, owned and raised by a member of the Big Knob Livestock Club. The breeds recognized are New Zealand and Californian. A meat rabbit pen will contain three rabbits of the same breed or mixed, and may be of different sexes. Does and breeding buck of the litters to be verified for meat pens must be designated project animals owned by the member. Meat pens must be at least 8 weeks of age but not more than 12 weeks of age on opening day of the fair. Meat pens must weigh at least 5 pounds but not to exceed 10 pounds at the time of judging. Meat pens will be judged on meat, type, condition of flesh, uniformity of body and weight, and fur.
